The Office of the Rural Municipal Executive, Siranchowk Rural Municipality Chhoprak, Gorkha invites Sealed Bids from eligible bidders for the following works.

- 2. To purchase the bidding documents, eligible Bidders should write to address above requesting the bidding documents specifying the contracts mentioned below on or before 17:00 hrs on 2076-12-16 and pay a non-refundable fee of NRs. 3000.00 (Three Thousand) for each set.
- 3. Sealed Bids must be submitted to the above office on or before 12.00 hrs on 2076-12-17
- 4. Sealed Bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2076-12-17 at the Office of the Rural Municipal Executive, Siranchowk Rural Municipality Chhoprak, Gorkha phone no. 9856010050
- 5. Sealed Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security for the amount as specified in clause 11 and valid for 30 days beyond bid validity period. If bidder wishes to submit bid security in the form of cash, the cash should be deposited at office bank account, Rastriya Banijya Bank (Dharauti), Gorkha, Account No: 3060303007109 and submit the receipt of the deposited amount of cash with the bid.
- 6. The quoted rates for each item in the sealed bid must be clearly written in both numeric value and words. If the quoted rates differ in numeric and words, preference will be given for the rates quoted in words. Authorized signature of the bidder is the must for any corrections made.
- 7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
- 8. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.
- 9. Any intimidation, collusion and curtailing during bidding process shall be punishable by law.
- Any conditions so far not covered shall be as per Public Procurement Act-2063 (Amendment 2071), Public Procurement Regulations-2064.
